

PRAIRIE GROUSE SYMPOSIUM

The Wisconsin Chapter of the Wildlife Society is sponsoring a grouse symposium on February 24, 1994 at UW Memorial Union, Madison. Wisconsin's native grouse, including the prairie chicken, sharp-tailed grouse, ruffed grouse and the spruce grouse, will be the subject of the symposium. Information on the life history, status, and management of the four grouse species will be presented.

A. Tax Exempt Status:

When I get it back I want to take it to the Milwaukee area, and hopefully get it into some of the nature centers that Tom Jancoski has connections with.

On February 5th The Nature Conservancy is sponsoring a one day workshop on "Northern Wisconsin Communities" at UW-SP College of Natural Resources. TNC called me last week and <u>invited</u> us to come down and set up our display board. Linda Parker from Park Falls USFS told them about it. It seems this display really sells itself. We are invited to participate in the meeting.

Maybe we can put display board back at Sandhill from Stevens Point to be displayed until our April annual meeting.




